The award or awards, and the terms of space, must be clearly stated on the entry/ballot form. Contest rules & regulations and a copy of the ballot form must be submitted for approval prior to November 1, 2017.

The following conditions must be clearly stated on the ballots:

- Approximate retail value of the prize
- No purchase necessary
- Not redeemable for cash
- Consent from the customer to be contacted for promotional purposes

Information obtained from ballots are to be used in the following manner:

Solely by the exhibitor who collected the information
Solely for the purpose mentioned on the ballot

Show management reserves the right to terminate any contest, by removing ballots and ballot boxes from the booth, if it does not comply with the competition act, or with show management regulations.
